Independent Sales Steward Contract Terms And Conditions

As an Independent Sales Steward of Blessed Holidays And Home, I agree to the following:

To actively promote the sale of Blessed Holidays And Home Products directly to consumers. I will present, promote and sell Blessed Holidays And Home Products in an honest and ethical manner. I will not make statements, claims or representations, or do any act that would impair the name, reputation or goodwill of Blessed Holidays And Home. I will NOT sell Blessed Holidays And Home Products for resale through third parties, any business entity or any type of retail establishment, or any Web site unless authorized by Blessed Holidays And Home in writing. I will not use or register, and do not own any keywords, metatags, or domain names that include, in whole or part, any of Blessed Holidays And Home trademarks including, without limitation, the name BLESSED HOLIDAYS AND HOME, and I hereby consent to transfer to BLESSED HOLIDAYS AND HOME any such domain names.

I am an Independent Sales Steward conducting my own business selling Blessed Holidays And Home products. I understand I am not and I will not be treated as an employee for federal, state or local tax or any other purpose. As an Independent Sales Steward conducting my own business I will be responsible for filing and paying my own federal, state and local, income, unemployment, workers' compensation, social security, self employment, and other taxes. I am responsible for all liability, health, disability, workers' compensation and other insurance. Blessed Holidays And Home, as a service provider to me, will aggregate the sales tax I have collected for remittance to the appropriate authorities. I am an Independent Sales Steward and I have no power or authority to incur any debt, obligation or liability, or make any promise or contract on behalf of Blessed Holidays And Home.

My relationship with Blessed Holidays And Home is set forth in this Independent Sales Steward Agreement. My earnings and success will depend upon my ability to sell the Products directly to consumers through home and church parties, one-on-one sales through the catalog, and through my sponsoring of other "Independent Sales Stewards" who sell Products. Blessed Holidays And Home has the right to discontinue Products or change prices, bonuses, discounts or incentive programs at any time. Blessed Holidays And Home reserves the right to change its policies at any time upon publication of the changes. By continuing to sell Blessed Holidays And Home Products, I signify my agreement to these changes.

I agree that I will make no statements, representations or disclosures while recruiting, sponsoring or training current or potential Independent Sales Stewards or in selling Products, other than what is explained in the Independent Sales Steward Plan. I will make no claims or representations of actual or potential earnings, guaranteed or anticipated profits or sales success. I agree that any earnings I receive from Blessed Holidays And Home or from its customers are attributable only to the sale of Products. I will not engage in any unlawful or unfair business practice or violate any applicable laws or regulations. I will not solicit or persuade any Blessed Holidays And Home "Independent Sales Stewards" or Leaders to promote or sell the products of another direct sales company while representing Blessed Holidays And Home as an Independent Sales Steward.

Except for catalogs, sales literature and sample Products which the Company sells or otherwise provides to me, I will not use or display the Blessed Holidays And Home logo, trademarks, trade names or copyrighted materials without prior written consent from Blessed Holidays And Home. I also agree that I will not use the name Blessed Holidays And Home for my personal business, or attempt to register a business using that name, or apply for a trademark application using that name. I will not use any proprietary or confidential information belonging to Blessed Holidays And Home during or after this Agreement. I agree that all such information is wholly owned by Blessed Holidays And Home and is strictly confidential.
